## Letter of Marque and Reprísal

This Letter, by Margrave Jaap Hendric, Commander in Chief, in and over Her Majesty's Province of Munner and its Wimranda Dependencies, Vice Admiral of the same, etc.; to all Worshipful and Honorable peerage of rank, as well as regional governors, judges, marshals, and commissioners within the eastern regions of The Queendom of Svarta; bearing the Date of 1215 Hardrada, and in the 40th säsong of Her Majesty's Reign; in accordance with Hundrasextiotvå Säsongskriget Treaty between Svartaland, Ökenveld , and Rimemarch according to the Laws of Nations; the Lords Commissioners for executing the Office of Lord High Admiral are required and authorized to issue forth and grant such Letters of Marque and Reprisal to any of Her Majesty's Subjects or others, whom we shall deem fitly qualified in that Behalf for apprehending, seizing, and the taking of Ships, Vehicles, and Goods rightfully belonging to The Queendom of Svarta, or to any Persons being Subjects of Svartaland (save and except for any Ships, Vehicles, and Goods to which Svartriki official license has been granted), and to bring the same to Judgment in any of Her Majesty's Courts of Admiralty with her Dominions, for Proceedings and Adjudication and Condemnation to be thereupon had, according to the Court of Admiralty, and the Laws of Nations. These are, therefore, to will and require and cause this Letter of Marque and Reprisals to be issued out of the High Court of Admiralty onto the private Marine Corps Company of

to apprehend, seize, and take the Ships, Vehicles, and Goods according to Her Majesty's Commission and Instruction aforesaid. Said company is to keep an exacting Journal of Proceedings, and therein particularly to take notice of all Prizes taken, the nature of such Prizes, the Time and Place of their being taken, the value of them as near as you can judge; as also the Situation, Motion and Strength of any forces participating in unauthorized war efforts against The Queendom of Svarta, those attempting to overthrow its legal government, spying on its military, its diplomats, or its secret services for any hostile or foreign powers, or attempting to kill its heads of state; as well as you can discover by the best Intelligence you can get; of which the Liaison Officer shall from Time to Time as Opportunity permits, to transmit an Account to our Secretary through proper, local channels. Provide always that security be given according to Her Majesty's Instructions before mentioned; these Said Letters of Marque and Reprisal to continue in force until further orders rescind, and, until then, for which this Letter shall be your Warrant.
