Welcome to the 2013 Sangamon County Jr. High Track and Field Meet!

1. The meet will begin at 9:00 a.m. There will be a coaches meeting in the East Bleachers at 8:30 a.m.
2. Our Track is a eight lane all-weather surface. The long jump and high jump runways are also all-weather surfaces. Athletes must use 1/4" or less spikes.
3. Team camps should be set up outside the fence on the West side of the track. No team camps should be set up in the bleachers. No boom boxes, footballs, Frisbees, or any other "toys" will be allowed.
4. Only officials and competitors will be allowed on the inside of the track.
5. Admission Fees: Adults and HS students \$4.00
 JH and elementary students \$2.00
 Senior Citizens \$2.00
6. Concessions will be located on the northast side of the track selling sandwiches, drinks, candy, etc. The Cubby Hole will be present to sell County Track and Field T-shirts.
7. Auburn CUSD No. 10 will not be responsible for lost or stolen items.
8. We will make every effort to conduct this meet on April 13, 2013. If the meet needs to be cancelled due to inclement weather, the **make-up date is Monday April 15th at 2:30.**
9. Parking is available at the east end of the track. Please have the buses park in front row of the east parking lot.

General Meet Information

1. We will provide starting blocks.
2. We will provide discus and shots.
3. All entries and season best time must be received by **Monday, April 8, 2013 by 10:00 p.m.** To enter your meet information go to www.sydexsports.com and click on "track online meet entries" to complete the process.
4. In events in which there are no prelims and there is more than one heat, the winners will be determined by best times.
5. Each school is limited to two athletes in each individual event and one per relay. There will be four divisions at the meet: 6/7th grade girls, 8th grade girls, 6/7th grade boys and 8th grade boys.
6. Scoring for the meet will be (10-8-6-4-2-1) in all events for all divisions. Ribbons will be awarded for the first six places in each event. The top four teams in each division will receive plaques.
7. Please bring enough people to conduct the events you have been assigned.
8. Even though there are only six places, we will have eight timers.
