# While You Were Gone... IBS Saved Your Streams!

The Recording Industry Association of America (RIAA) and the Intercollegiate Broadcasting System (IBS) signed an historic agreement a few minutes before midnight on Saturday, May 31, 2003. A copy of the agreement and the details for IBS member-stations are on the IBS web site (http://www.ibsradio.org) which is updated daily.

IBS promised its 800 Member radio stations and webcasters that the we were working towards a copyright streaming fee that would be a fixed low reasonable annual payment, just as we had achieved in the 1970's with ASCAP & BMI for FM educational broadcasting. IBS had also reassured members that we felt recordkeeping/reporting would be no problem. We're happy to report that our negotiations were successful and that these issues have been resolved.

The current 2003 annual fee due to SoundExchange (the agency responsible for the RIAA collection) is \$250. There is an additional fee of \$50 in lieu of all recordkeeping and reporting from 1998 through 2003. That fee is reduced 50% to \$25 for 2004.

IBS will provide all of our memberstations with a special IBS reduced rate SoundExchange Statement of Account and sign up form, which must be mailed in with the station's webcasting fee by October 15, 2003.

These results on your behalf confirm that it pays to be an IBS member-station. IBS is the only educational radio association with full time Washington, DC legal counsel. IBS has had a continuous Washington, DC presence for over 60 years. We are your experienced resource.

# Annual Reminder: FCC Could Visit Your Station

Is your station ready for a possible visit from the FCC?

As unlikely as that may seem, a surprise visit from the FCC does happen. They may be visiting your area in response to a complaint about another station. Or, it just could be that they haven't visited stations in your area for a while, and it's time they did.

In any case, be sure you're ready to show them your local public file, your log of EAS (Emergency Alert System) tests conducted and received, and your station license. These are among the most common problem areas they find during station visits.

Also, be sure to have a copy of "The Public and Broadcasting" a booklet required to be on hand. You'll find a link to a .pdf file with this booklet on the IBS web site.

HR Bill1417 and Webcasting
A new Bill introduced in Congress earlier this year is the result of the
Congressional Copyright Office and the
Washington, DC copyright legal community, including, IBS.

While not a problem for IBS Member webcasters, remaining "content restrictions" of the Digital Millennium Copyright Act do need to be cleaned up, or eliminated. H.R.1417 may well be the legislative vehicle to do this. The Bill is in House Committee and has completed markup. As always, IBS will be working for you on this and other Washington, DC concerns.

IBS correctly predicted low fixed rates and no recordkeeping or reporting for our member-stations. Others said rates would be thousands of dollars annually and reporting would include 50 pieces of information on every song streamed. The fear mongers caused many non-IBS member webcasters to close down, losing the vast education and entertainment benefits of streaming audio.

We'll continued to work on your behalf regarding HR 1417 and let you know the details as they happen.

#### **FCC News**

#### Quarterly Issues/Programs List Due in Public File by October 10th

Every 3 months, licensed, non-commercial FM stations must put in their public file a list of significant problems in their community that were addressed by their programming. The list must include issues, dates, times, titles and lengths of each broadcast. You've got 10 days after the calendar quarter ends to get the list into your public file. It's a good idea to keep track of those PSA's, public service and call-in shows, because it's likely that you will not remember them all after 3 months. For this academic year, the dates are as follows:

**July-Aug-Sept, 2003** – List must be in the Public File by Oct 10, 2003

Oct-Nov-Dec, 2003 – List must be in the Public File by January 10, 2004

**Jan-Feb-Mar**, **2004** – List must be in the Public File by Apr 10, 2004

**April-May-June**, **2004** – List must be in the Public File by July 10, 2004

#### License Renewals

Appearing July 23rd before the Senate Commerce Committee, FCC **Commissioner Michael Copps** announced that he plans to conduct "town meetings" in communities whose local radio stations' licenses are up for renewal. Copps' goal? To find out if those stations are serving the public interest. According to Copps, "The FCC grants so-called 'postcard' renewals after a minimal review and no public outreach to local communities". The FCC renews licenses for eight-year terms. **Commissioner Copps and Commerce** Committee Chair Sen. John McCain have both suggested the possibility of reducing the license term so stations' community service efforts can be reviewed more frequently. Reminder...If you have a question regarding the FCC's license renewal process and the time deadlines as they apply to your station, contact the IBS office or web site for more information.

At the same July 23rd appearance, Commissioner Copps called on the National Association of Broadcasters and the National Cable Television Association to convene a joint summit to address the issue of broadcast indecency. Copps said that he plans to propose a proceeding to investigate whether a connection exists between increasing consolidation in media and indecency on the air.

#### **Phone Etiquette**

The FCC recently fined WBLK-FM, Buffalo, NY \$4,000 for broadcasting a telephone conversation without FIRST informing the party on the "other end" that she would be on the air. FCC rules regarding the broadcast of telephone calls in a variety of contexts (news, listener requests, "open line" shows) can be confusing and can lead to FCC sanction. Contact IBS if you have questions about this very important programming area.

In other FCC news, the Commission will provide free wireless internet access to visitors at its Washington office (445 12th Street SW). The Commission will be unable to provide technical support and all transactions using this service are the responsibility of the visitor. At present, the FCC will not request personal identifying information prior to allowing access to the wireless network. Their phone number is: 212-264-3825. This printed edition is updated to October 1, 2002. Of course, this info is also available online, but the posted edition may not have been updated yet. You may also find a printed copy in your school, college or city library, altough they will probably not let you take it out.

Clear Channel connects with non-commercial radio! Eyebrows were raised recently when it was announced that major commercial radio station operator Clear Channel will be handling the underwriting operations of non-commercial KUSC-FM in Los Angeles. According to KUSC, the arrangement will cut costs from the classical station's budget while taking advantage of the reach and range of Clear Channel contacts. KUSC will retain control of the underwriting spot content and no spot will exceed 15 seconds in length. We at IBS would like to hear your opinions on the KUSC/Clear Channel agreement. In other underwriting news, public radio listeners are bothered more by the length and frequency of underwriting credits than they are by the language used in them, according to research commissioned by National Public Radio and consulting firm Jacobs Media. According to the study, audiences rank tone, length and frequency of spots as more important factors in determining whether a non-commercial station sounds "too commercial". Listeners also prefer underwriting language that promotes the company - which they see as "informative" - to wording that promotes a product, which listeners see as "selling".
