## 'SAFE Act 1' and 'SAFE Act 2'

## MANAY 2COHOUNTOLA

- 1. Confiscation of "assault weapons" ["Confiscation could be an option" Cuomo 12/21/12]
- 2. Confiscation of ten round magazines
- 3. Statewide database for ALL guns
- 4. Allow pistol permit holder's information to be released to the public
- 5. Semi-auto shotguns w/more than 5 rounds or pistol grips are "assault weapons'
- 6. Limit the number of rounds in a magazine to 5
- 7. Limit possession to no more than two (2) magazines
- 8. Limit purchase of guns to one gun per person per month
- 9. Require re-licensing of all pistol permit owners
- 10. Require renewal of all pistol permits every five (5) years
- 11. State issued pistol permits
- 12. Microstamping of all semi-automatic pistols sold in NY state
- 13. Require licensing of all gun ammo dealers
- 14. Mandatory locking of guns at home
- 15. Fees for licensing and registering weapons

## All 15 and the existing bills below offer a preview of 'SAFE Act 2'. Read on:

- 1. Requires firearms to be stored with a safety locking device or in a safe
- 2. Microstamping [will drastically reduce sales in NY by out of state manufacturers]
- 3. Ban of 50 Caliber OR LARGER weapons [Read as 12 gauge / e.g. .87 caliber]
- 4. Gun Dealer liability Insurance of at least \$1 million
- 5. Prohibits the sale or transfer of a "child operated firearm"
- 6. Limit buyers to purchasing maximum of one gun in a 30 day period
- 7. 10 day waiting period on all firearm purchases despite passing NICS check
- 8. Prohibits "undetectable firearm/rifle/shotgun or any undetectable components"
- 9. Family offense conviction strips you of all firearms [e.g. harassment]
- 10. Mandates purchase of \$250,000 minimum liability insurance by gun owners
- 11. Requires renewal of all pistol permits every two (2) years
- 12. Registration of ALL firearms with \$15 fee/gun and annual renewal with \$10 fee/gun
- 13. Prohibits anyone under age of 12 from entering a gun show
- 14. Requires ammo coding for handguns and "assault weapons" [recall failed CoBIS]
- 15. Many more...
