

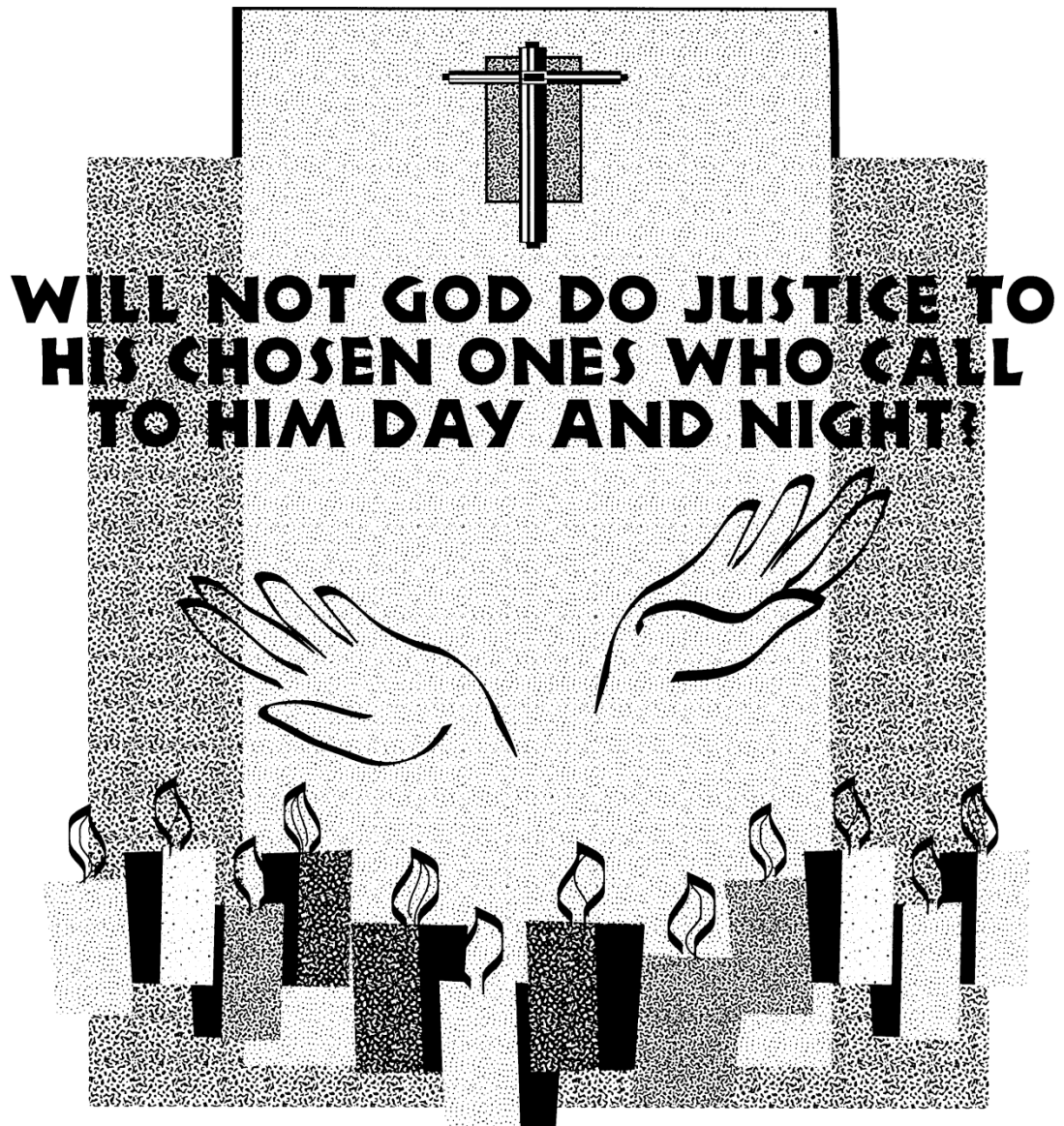
Twenty-Ninth Sunday in Ordinary Time

Pray always without becoming weary. In today's gospel, Jesus tells a parable to the disciples about a courageous widow who had a strong sense of justice and keeps asking for help. The lesson for us is clear – persistence works! The judge did not help the widow because he suddenly became sensitive or concerned. He simply didn't want to be bothered anymore!

The issue is perseverance. A helpless, persistent woman does not lose heart but continues to plead her case. The judge relents and she is victorious – not because she has proven her case but just because she won't give up. Jesus also explains that if such an uncaring judge makes the right decision, we certainly can trust our loving God to help us. Maybe God will not answer our prayers as we'd like or perhaps not as quickly as we'd want, but we can be assured that they will be heard and answered. Our awesome God is not like this crooked and bored judge – God is always ready and eager to listen to our prayers. God's love is constant, unconditional and persistent. We needn't lose heart and we mustn't lose faith. Trust God and keep praying!
