# INFORMATION/SCHEDULE OF DUES

Annual dues for member 18-69 is \$75.00 with current NRA membership.

Dues for members age 70+ are \$55.00 with current NRA membership and expiration date + date of birth.

Dues for married couples living at same address are \$130.00 with current NRA membership.

Dues for married couple with one age 70+ are \$95.00 for both with NRA membership.

Dues for married couple with both age 70+ are \$90.00 with NRA membership along w/date of birth.

Dues for Junior memberships (age 10-17) are \$1.00

2007 bylaws changed to read all new members must be a member of the NRA. Dues for members pre" September 2007 that are not NRA members are \$90.00 (\$70.00 for those 70 and older) Members may enroll or renew their NRA membership through the club.

Dues shall be collected at the club every Monday and Wednesday except holidays from 5PM to 7PM through January. members may also submit dues by mail:
